## LASU: CACOL Backs Falana Over Reduction Of Tuition Fee

Corrupt Leaders has thrown its weight behind the plea for the reduction of the Lagos State University (LASU) tuition fee.

Mr. Femi Falana (SAN), a human rights lawyer made this plea to Lagos State governor, Babatunde Fashola, in a statement on Sunday.

The Coalition Chairman, Comrade Debo Adeniran, who faulted the hiked tuition, decried the inhumanity of the State government to the Lagosians.

Adeniran also blamed that the government has remained adamant in the form of policies, which he described as 'antipoor policies'.

In his word, "We have said it times without number that the anti-poor policies of the Lagos State government is having a bad effect on an average Lagosian. Whatever warranted the hike in the tuition fees of Lagos State University is not tenable. Every policy of government must be given human face. The minimum wage of a Nigerian worker is a paltry N18, 000.00 whereas many Nigerians, by extension Lagosians, are living below \$1 per day. How many of these people can afford to raise a tuition of N250, 000.00?

"It is so unfortunate that education is only for the children of rich in Nigeria while the unfortunate ones from poor families will have to stay outside no matter how





#### **Unremitted \$20bn: CACOL Demands Alison-Madueke's** Suspension

nti-corruption group, the Coalition Against Corrupt Leaders (CACOL) on Thursday commended President Goodluck Jonathan for approving the forensic audit of the Nigerian National Petroleum Corporation Accounts (NNPC) over the allegedly unremitted \$20bn but called for the suspension of Minister of Petroleum Resources, Mrs. Diezani Alison-Madueke while the probe is ongoing.

The group described the approval the forensic audit of NNPC's books as a step in the right direction, since the corporation is a "known drain pipe" to the coffers of the country.

"This audit will not only unearth the whereabouts of the missing \$20bn, but it will also make transparent, the accounts of the NNPC and other government agencies", Executive Chairman, Mr. Debo Adeniran

"It is a good thing that independent bodies are going to find out what happened to the missing money and even digging into the books of the NNPC and her sister agencies".

However, he expressed scepticism on the implementation of the audit report, considering that the account of NNPC has been audited many times in the past, WITH all indicating monumental corruption and the Federal Government failing to take decisive

"The KPMG report on NNPC carried out in 2010, the 2012 Nuhu Ribadu Report on NNPC, [and] the Berne Declaration Report all indicted the NNPC of massive corruption and sharp practices and nothing has been done to those indicted in the probes", he recalled.

"Minister of Petroleum, Mrs. Diezani Alison-Madueke and others fingered in the previous probes should be asked to step aside if the forensic audit would be successful and meaningful.

"For any successful audit to be carried out, the petroleum minister and others who are suspects should step aside. Otherwise, the audit will just be efforts in futility as those auditors may be compromised at the end of the day. The report of the audit should be handed over to the anti-graft agencies for apposite prosecution of anyone found to have abused his office".

Special Adviser to the President on Media and Publicity, Dr. Reuben Abati announced on Wednesday that President Goodluck Jonathan has sanctioned the contraction of "reputable international firms" to audit NNPC's accounts, but gave no further details.







# Confab: 'N4m per month for delegates too much'- CACOL

he Coalition Against Corrupt Leaders has reacted to reports that the Federal Government had earmarked the sum of N4m monthly on each of the 492 delegates to the national

The Executive Director of CACOL, Mr. Debo Adeniran, said the amount was too much, adding that each group should sponsor its delegate to the conference.

Speaking in a phone interview with SUNDAY PUNCH, Adeniran said CACOL was opposed to government spending N7bn on the conference. He said, "The hosting of the conference itself is too expensive than it is supposed to be. They have budgeted about N7bn, and if each delegate will be paid up to N4m per month, that accentuates the profligacy going on in the National Assembly, where members who are doing part-time jobs are taking more than full-time

"Every section of the society that sends a delegate should have been asked to fund their delegates. It is not supposed to be a money-making venture to the extent that bribery and corruption will now pervade the atmosphere."

Adeniran said monetising the conference would make the delegates compromise the stand of their people for the stand of the authority paying them.

However, the Executive Director of the Civil Liberties Organisation, Mr. Ibuchukwu Ezike, who is also a delegate to the confab, said it was speculation that such an amount had been earmarked for them.

The Executive Chairman of the Coalition, Mr. Debo Adeniran, described the audit approval as laudable though belated.

Adeniran also said though it is a known fact that NNPC has been a

## Nigerians Slam Goodluck Jonathan Over Media Chat Answers

The President had stated that he had absolute power to suspend the Governor of Central Bank, Sanusi Lamido Sanusi.

He suspended Sanusi last week over some allegations that the latter claimed he was not aware of.

Jonathan also condemned governor Kashim Shettima of Borno State for saying the Boko Haram terrorists currently waging war in his state were more armed than the Nigerian

soldiers, saying he could remove the soldiers from the state for one month to know if the governor would remain in office.

"If governor of Borno feels the military are that useless against Boko Haram, I can pull out the military for one month and see what happens there and after I can send the military back to take charge.

The governor should be sensitive in his choice of words. It's u n f o r t u n a t e," Jonathan had said.

Former Vice President Atiku Abubakar, in his reaction, said he expected the President to even show some emotional attachment to the victims of the

Boko Haram massacre "I deeply respect the office of the president, but I believe the Commander-In-Chief needs to show some more compassion for the affected families.

The 20 abducted school girls still remain unfound. A word of compassion would have given hope to their families. I'm very sad," he said on his Twitter handle.

Former Minister of Aviation, Femi Fani-Kayode, said Governor Shettima is only asking for more help and more troops from the Federal Government because hundreds more of his people are being killed and abducted everyday by the Boko Haram "and this is the best response that our President can give to him?"

"Are those being killed and abducted not Nigerians? Would this have been his response if 8000 of his own Ijaw people had been killed in the last three years by a

terrorist organisation? May God save and deliver Nigeria," he said in a post attributed to him on Facebook.

Popular rights activist, Biodun Sowunmi, said that though the President's presentation was better than before, he only ended up drawing himself into more controversies over the sack of Sanusi.

He said the President goofed as he should have declined commenting after being told that Sanusi had gone to court since it would

subjudice.

He also carpeted the President for saying he had the power to suspend Sanusi, because according to him, the only way he could have done that was if Sanusi's professional body derobed him as stipulated in the CBN Act.

Concerning his response on the carnage in Borno, Sowunmi said he was surprised that President Jonathan had refused to visit the scene like it is done by presidents in other climes, but could utter statements threatening the state governor for his own inability to curtail terrorism as the Commander-In-Chief.

"It is the governor who had been visiting the places and he is rightly emotional," he said describing Jonathan's statement as unfortunate

Sowunmi, who said he was not defending Sanusi, said the CBN Governor acted in line with the constitution that all monies should be remitted to the federation account first, which the NNPC and other related agencies disregarded.

"What Jonathan did with his responses was to try to divert attention from the missing \$20 billion," he added.

President of the Coalition Against Corrupt Leaders, CACOL, Debo Adeniran, supported Sowunmi, adding that the only area the President responded well

was on the National Conference in which he said he did not want to preside over a disintegrating country.

"Every other response was halftruth, borne out of arrogance, justification for insolence, watery and untenable," he said, adding that the President must remember that nobody has absolute powers as he had claimed.

Wondering why it took the President Sanusi's whistle-blowing for him to know that Sanusi had committed some infringements, he said the way the President chastised Shettima was a show of arrogance and ploy to suppress the truth instead of working on what the governor said.

He recalled that the Deputy Governors at the CBN were also indicted but that the President chose to punish only Sanusi, saying the President should also step aside for the corruption

scandal that has enveloped his government to be investigated.

"Look at the power project that has gulped over \$16 billion, look at Arumna Oteh of Securities and Exchange Commission, look at Diezani Alison-Madueke and Jonathan is attacking those who blew the whistle leaving those accused of corruption," he lamented.

Shettima Yerima of the Arewa Youth Consultative Forum, simply said: "it would be shameful if President Jonathan can prove that Sanusi soiled his hands while at the CBN, but if at the end of the investigation, he is not found wanting, then the President should be prepared for the anger of the north because he molested their son."

On Jonathan's reaction to the Borno attack, a Nigerian, Eweje Alli, said: "I saw the interview and was shocked to hear those words coming from the President of a Republic. God help Nigerians."

he Minister of Petroleum Resources, Mrs Diezani Alison-Madueke can safely be referred to as the most controversial minister in the President Goodluck Jonathan administration ever since her appointment and Most of the allegations against her have to do with spending of government money.

Since her appointment, she has continued to face stiff opposition from the opposition parties, civil society organisations and various individuals over the way and manner she is managing the nation's most precious resource.

Before now, civil society groups under the aegis of Coalition Against Corrupt Leaders (CACOL) had petitioned the Economic and Financial Crimes Commission (EFCC) calling for the immediate probe of the Minister. The Executive Chairman of CACOL, Mr Debo Adediran, in a three-page petition to the EFCC, had asked the antigraft commission to investigate the alleged deals between the minister and other oil companies as well as the high rate of oil theft in the industry.

The group, in the petition, noted that, "Since Allison-Madueke's appointment, Nigeria is reporte

to have lost billions of dollars. So has been frittering away scarce much noise has been made from various quarters, which include the House of Representatives, without any significant response whatsoever. An invitation from the hallowed chambers to the

minister was 0 honoured."

And recently another group, Concerned Aviation Professionals (CAP)petitioned President Jonathan on the need to investigate the minister and copied both Senate president and the speaker of the House of Representativ

The group's petition was signed by Abdul Malik Masaya and John Anihinru, chairman and secretary respectively, and it was averred in the petition that, "We have details and impeccable records which confirm that the 'Super Minister'

While moving the motion, Adejare also noted that "in these days of scarce national resources where public finance is shrinking in the face of ever increasing national needs such as roads, health, education and power, amongst others an official of government could waste public funds on such luxury as chartering a Challenger 850 Aircraft for extra official use."

### N24bn police pension: Solomon Olamilekan, there are no verifiable documents before the committee to track the Okonjo-Iweala brandishing fake documents -Reps

he House of Representatives Committee on Public Accounts on Thursday accused the Minister of Finance, Dr Ngozi Okonjo-Iweala, of "brandishing fake and forged documents" in her defence of the alleged missing N24bn from Police Pension Fund.

The committee had resumed sitting on the investigation on Thursday with theý Director-General of Pension Transitional Arrangement Department, Mrs. Nellie Mayshak, and representatives of the Office of the Accountant-General of the Federation in attendance.

Members of the committee at the session argued that the minister was misleading Nigerians with her claim that the money was not missing but paid into bank accounts.

According to the Chairman of the committee, Mr.
