he Centre for Anti-Corruption and Open Leadership, CACOL, has called on the Federal Government, the Economic and Financial Crimes Commission, EFCC, the Independent Corrupt Practices Commission, ICPC and other relevant agencies to immediately activate the processes that will urgently resume the trial of ex-convict James Ibori, former governor of Delta state for the corruptions allegations against him.

News broken today by the media, reported the return of the ex-convict James Ibori, a former governor of Delta state, upon the completion of his term over money laundering charges. Mr. DeboAdeniran, Executive Chairman of the Centre said


"CACOL's immediate reaction which is what we had always maintained is that all the cases against Ibori in Nigeria should be re-opened."

"This is very important considering the

effrontery represented in Ibori's dare to return to the country like some 'hero'. The shame and consequence of the delay or failure to act now is better imagined than seen."

"Any dilly-dallying would put a bigger question mark on the anti-corruption drive than hitherto known, given that as far back as July last year, the EFCC was already talking about reopening Ibori's. So there is no reason why reopening Ibori's cases should be delayed, because the FG, EFCC and other agencies also followed the UK trial and conviction of the former governor who cunningly wiggled through the judicial labyrinth in Nigeria." He said

Last year July, the Federal Government according to media reports, in line with its anticorruption drive decided to reopen corruption



cases against former Delta state governor, James Ibori and 30 other former governors. The Federal government had said it had taken the step through the Office of the Attorney General of the Federation and Minister of Justice, in a

> letter written to the ICPC. instructing the Commission to forward the case files of all former governors that are standing trial for corruption.

Concluding, CACOL's chairman said "In fact we believe all preparations should have been completed prior to the convict's return to the country. Our demand

he Centre for Anti-Corruption and Open Leadership, CACOL has described the 'euphoria' that greeted the return of the ex-convict, Mr. James Ibori, a former governor of Delta state as a show of shame that debases humanism.

We also point out that the 'welcome carnival' is a manifestation of a tendency that can never spell any good for socio-cultural, economic and political development because the trend is predicated on corruption and abysmal disregard for core values and morals.

So unlike of the spokespersons of that obnoxious tendency, who say 'lbori's coming is a beginning of so many good things to come', we say that his return can only mean good when he has answered to all the corruption cases against him

"Does the government need education to know that the 'ordinary' tomato sellers will pay astronomic rates for transporting his/her items in vehicles running on fuel that now cost about 200% of what it used to cost? Do the thinkers for this government know that those doing business in the food sector all also have needs to access services from other sectors which the government has gladly handled over to private hands that have priced their services out of their reach in the name of privatization and deregulation?"

"The Federal Government recently set up a task force on food security with the objective to look at the causes of increase in the prices of food items across the country with a view to addressing them."

"The government

must abandon its neo-liberal fixation as the only way to address the economic issues of the country. The government must play the role it was elected and instituted for which is the social well-being and security of the people. Erstwhile leaders of our country against all odds invested heavily in food production and that was why agriculture was the mainstay of the productive economy that prevailed in the past. The present government appears not ready to act in trying to achieve such remarkable feats but prefers to slogan on returning agriculture to its days of glory."

"There is no task force in the world that can 'force' down the prices of food items without first fulfilling the obligatory social conditions to do that!" Mr. Adeniran affirmed
